THE ARCHDIOCESE OF CINCINNATI

DECREE

Having consulted the Presbyteral Council of the Archdiocese of Cincinnati on May 12, 2014, and the parochial administrator of Corpus Christi Parish and Our Lady of Mercy Parish in Dayton, Ohio who earlier has consulted the parish council and parishioners, I have determined that the pastoral mission of the Catholic Church in the Archdiocese of Cincinnati would best be served by erecting Our Lady of Grace Parish in Dayton, Ohio and merging Corpus Christi and Our Lady of Mercy Parishes into Our Lady of Grace Parish.

Taking into account the supreme law of the Church, i.e. the salvation of souls (canon 1752), it is my belief that the new parish, Our Lady of Grace, will add a sense of vibrancy to the pastoral ministry in Dayton, Ohio.

In virtue of my office as diocesan bishop, in accord with canon 515 §2 of the 1983 Code of Canon Law, I hereby decree the erection of Our Lady of Grace Parish and the merger of Corpus Christi and Our Lady of Mercy Parishes into Our Lady of Grace Parish.

I further decree that all the assets, including *bona sacra* and religious articles, and liabilities of Corpus Christi and Our Lady of Mercy Parishes, shall belong to the new Our Lady of Grace Parish. The territory of Corpus Christi and Our Lady of Mercy Parishes shall be combined and become the territory of Our Lady of Grace Parish. The current parochial administrator remains responsible for the assets and liabilities of the two parishes until September 14, 2014. Effective September 15, 2014, the parochial administrator of Our Lady of Grace Parish is charged with the supervision of the temporal goods of Our Lady of Grace Parish in accord with the universal law of the Church and the law of the Archdiocese of Cincinnati.

I further decree that the sacramental records of Corpus Christi and Our Lady of Mercy Parishes be transferred to Our Lady of Grace Parish. A new set of sacramental registers is to be inaugurated effective September 15, 2014 for Our Lady of Grace Parish.

I further decree that Our Lady of Grace Parish initially will worship in the two parochial churches which will remain dedicated to the same titles of Corpus Christi and Our Lady of Mercy. Each church may serve as the site for all the Catholic liturgical rites properly celebrated, and each may be fully furnished for these rites, according to the needs of Our Lady of Grace Parish. Likewise, the Blessed Sacrament may be reserved in each.


The people of Our Lady of Grace Parish, under the leadership of their parochial administrator, are to strive diligently, with God's help, to form a unified harmonious congregation dedicated to fulfilling the mission that Jesus Christ committed to his disciples.

I hereby decree that the territory of Corpus Christi Parish in Dayton and Our Lady of Mercy Parish in Dayton will go to the Our Lady of Grace Parish, Dayton.


Parishioners of the former parishes of Corpus Christi and Our Lady of Mercy are to associate themselves with their proper territorial parish, Our Lady of Grace, or another parish of their choice in accord with universal and diocesan law.

This decree will take effect on September 15, 2014 and is to be published immediately such that all members of Corpus Christi and Our Lady of Mercy Parishes will be properly notified.
